# Section 161 of the Securities Act, RSBC 1996, c. 418

#### Introduction

¶ 1 This is an order under sections 161(1) and 161(6)(c) of the *Securities Act*, RSBC 1996, c. 418.

#### Background

¶ 2 Ronald Theodore Cloutier is subject to an order made by the Alberta Securities Commission on May 5, 2014 in *Cloutier, Re, 2014 ABASC 170*.

### Order

- ¶ 3 After providing Cloutier an opportunity to be heard, and considering staff's submissions, and considering it to be in the public interest, we order:
  - 1. under section 161(1)(b) of the Act, that Cloutier cease trading in, and is prohibited from purchasing securities permanently;
  - 2. under section 161(1)(c) of the Act, that any or all of the exemptions described in the Act or regulations do not apply to Cloutier permanently;
  - 3. under section 161(1)(d)(i) and (ii) of the Act, that Cloutier resign any position he holds as a director or officer of any issuer and is permanently prohibited from becoming or acting as a director or officer of any issuer; and
  - 4. under section 161(1)(d)(iv) of the Act, that Cloutier is permanently prohibited from acting in a management or consultative capacity in connection with activities in the securities market.
