## **NOTICE OF APPROVAL**

### **MINIMUM INTERACTION SIZE AND MINIMUM QUANTITY FEATURES**

#### **Introduction**

TSX Venture Exchange Inc. (“**TSXV**”) will adopt, and the Alberta Securities Commission and British Columbia Securities Commission have approved, certain amendments to the functionality of the Minimum Interaction Size and Minimum Quantity features on TSXV, as set out in the Notice of Proposed Amendments and Request for Comment (the “**Request for Comments**”) published by TSXV (the “**Amendments**”).

Capitalized terms used and not otherwise defined in the Notice of Approval shall have the meaning ascribed to them in the Request for Comments.
