CONSENT SETTLEMENT AND ORDER

WHEREAS by Notice of Hearing dated March 9, 1988 under sections 144 and 145 of the Securities Act, S.B.C. 1985, c.83 ("Act") the Superintendent of Brokers ("Superintendent") initiated proceedings before the British Columbia Securities Commission ("Commission") against Cathryn J. Garcia and others in connection with Marathon Minerals Inc;

AND WHEREAS the Superintendent and Cathryn J. Garcia have agreed to a settlement of the proceedings before the Commission in accordance with the following terms and conditions;

NOW THEREFORE:

1. Cathryn J. Garcia agrees and undertakes that she will not act as a director or officer of any reporting company for a period of 6 months from the date of this Consent Settlement and Order;
2. Cathryn J. Garcia agrees and undertakes that before again acting as a director or officer of any reporting company she will successfully complete the Justice Institute of British Columbia course on Duties and Responsibilities of Directors and Officers of Exchange Issuers;
3. Cathryn J. Garcia agrees and undertakes to pay forthwith to the Consolidated Revenue Fund of the Province of British Columbia the sum of

\$2,000.00 towards the costs of the investigation of her affairs by the staff of the Commission;

- 4. Cathryn J. Garcia agrees to waive her rights to a hearing and review in this matter;
- 5. The Superintendent, being of the opinion that this Consent Settlement and Order is in the public interest, agrees to discontinue the proceedings before the Commission as against Cathryn J. Garcia, providing that she will attend and testify as a witness as required from time to time with respect to the proceedings before the Commission and any related investigations by Commission staff.
