 - (c) in subsection (1) (b) by striking out "reporting issuer" and substituting "non-redeemable investment fund", and
 - (d) in subsection (8) by striking out "including a" and substituting "that is a non-redeemable investment fund, or".
- Effective May 20, 2005, section 145 (1) is amended by striking out ", including" and substituting "that is a non-redeemable investment fund, or".
- 5 Effective May 20, 2005, section 152 is amended by adding "that is an investment fund" after "exchange issuer".
