## Notice and Request for Comment

# Consultation on the British Columbia Securities Commission BCP 15-601 Policy outlining procedures for hearings under the *Securities Act*

### Introduction and Background

The British Columbia Securities Commission (**BCSC** or **we**) is consulting on proposed amendments to its existing procedures for hearings under the *Securities Act*. Those procedures are set out in the current BCP 15-601, a policy that has been effectively unchanged since 2010.

Over the past year, we have reviewed the existing BCP 15-601 with regard to updating its contents to better reflect:

- Recent Court and Commission decisions,
- Developments in electronic hearing technology, and
- Clarification of expectations for hearing participants, in particular self represented parties.

### **Policy Revisions**

The proposed amendments to BCP 15-601 address both content as well as organization of the policy. The order of some of the section headings have changed to better reflect the usual progression of hearings before the Commission, including: preliminary matters, hearings, reviews, and post hearing application.

More significantly, the proposed amendments to the policy incorporate substantive changes, including:

- A new statement of principles at s. 1.2
- A new section on the **appointment of panels** at s. 2.3
- Clarification of BCSC expectations relating to **preliminary applications** (including adjournment applications) at s. 3.4
- Updated descriptions of the BCSC electronic hearing process at s. 3.7
- A new section on BCSC expectations for written and oral submissions at s. 4.4
- Updated descriptions of the reciprocal order process at s. 5.2

- Substantial clarification of the **review process**, including process, timing for delivery of materials and the requirements for introduction of new evidence at s. 7
- Codification of:
  - BCSC requirements to attend hearings by video conference or by telephone at s. 8.2
  - BCSC policy relating to access to exhibits at s. 8.4(b)
- Updated guidelines for issuing rulings and decisions at s. 9.3
- A revised section relating to "Post Hearing Applications" at s. 9.10

We invite comments on the procedures for hearings before the Commission outlined in the proposed amendments to BCP 15-601.
